7. Filterpro may use the services of Baycorp or any other credit reporting service to carry out a credit check and any information given to Baycorp or any other credit reporting service may be used to update their information for their credit reporting service.
8. Should you fail to pay the account in full on or before the due date Filterpro Ltd reserves the right to review your credit facilities and you indemnify Filterpro and pay all costs and expenses which we may incur recovering any overdue account.
